1 General Terms and Conditions

2 Prices

The prices indicated in the Spare Parts Catalogue are not binding. Kässbohrer reserves the right of price alterations. All prices include delivery ex works Eugendorf, untaxed, duty unpaid, not packed. Discount levels are based on the valid and confirmed individual agreements.

The Electronic Spare Parts Catalogue with web shop represents Kässbohrer's primary information and order system. If standard orders are not processed using this medium, Kässbohrer reserves the right of price alterations due to the administrative extra expenses.

3 Additional costs

Expenses for packing and shipment are not included in the prices indicated in the Spare Parts Catalogue. KTT reserves these rights:

- Alteration of the type of shipment chosen by the customer for his order
- Addition of the expenses for packing and shipment to the invoice amount.

4 Payment conditions

The agreed and existing payment conditions shall apply.

Furthermore, Kässbohrer does not accept any liability if certain parts listed in the Spare Parts Catalogue are not available.
